The resident profile of those who live in assisted living today varies greatly from those "pioneers" in the early 1990's and regulations need to reflect those changes. Having said that, NJ crafted a model set of regulations in those early years that have withstood the test of time and HCANJ does not anticipate many dramatic changes to the current regulations which are scheduled to expire February, 2014.

MLTSS

HCANJ has been notified that the new launch date for the Managed Long Term Supports and Services (MLTSS) waiver, including assisted living, is January 1, 2014, except for nursing facilities which will be implemented in July 2014. Unfortunately, many questions remain unresolved and HCANJ continues to remain involved with decision makers. The MLTSS Steering Committee has reconvened with the stated intent of moving towards implementation of the waiver.

HCANJ members are encouraged to contact the Association for additional information as well as to attend Association meetings where the progress of the Waiver, as it's currently known, is discussed. HCANJ will continue to closely monitor developments related to the Waiver's approval and keep our members informed regarding implementation of the Waiver. Training and education programs will be announced as specific details related to implementation are made available to HCANJ.
