HCANJ BUSINESS MEETING LEGISLATIVE AND REGULATORY UPDATE December 14, 2022

1. <u>Rule Adoptions</u>

• <u>The Division of Consumer Affairs State Board of Social Work Examiners adopted</u> <u>new rule N.J.A.C. 13:44G-4.7 to establish standards as to when the Board may</u> <u>consider an application for licensure or certification abandoned.</u>

Pursuant to this rule adoption, an application for a license or certificate will be deemed abandoned if an applicant has not submitted all of the information and documentation required to obtain a license, and one year has elapsed since the last notice was sent to the applicant regarding the deficiencies in the application. Additionally, an application for a license or certificate will be deemed abandoned if the applicant has not submitted to the Board all of the information and documentation required to obtain a license and has not submitted any documentation in furtherance of the application since January 1, 2018.

Notice of this adoption appears in the September 19, 2022, *New Jersey Register* at 54 N.J.R. 1818(a). The effective date of the new rule was September 19, 2022.

• <u>The New Jersey Board of Respiratory Care adopted without change proposed</u> <u>amendments to and rules governing its licensees, N.J.A.C.13:44F</u>,

The adopted amendment at N.J.A.C. 13:44F-8.1 reduce the fee for a duplicate license from \$50.00 to \$25.00. The Board also approved amendments at N.J.A.C. 13:44F-8.5 to require licensees to provide the Board with their business address and to update the Board when either a residential or business address changes. Amendments adopted at N.J.A.C. 13:44F-10.2 recognize nine examinations that can be completed in order to obtain continuing education credits and recognize that licensees earn 10 credits for completing such examinations (rather than one credit).

Notice of this adoption appears in the October 3, 2022, *New Jersey Register* at 54 N.J.R. 1917 (a). The rule readoption took effect August 25, 2022, and the adopted amendments on October 3, 2022.

• <u>The Department of Labor and Workforce Development, Division of Wage and Hour</u> <u>Compliance, published notice of approval of an administrative change, effective</u> <u>January 1, 2023, increasing the minimum wage to not less than \$14.13 per hour or the</u> <u>minimum wage rate set by section 6(a)(1) of the Federal Fair Labor Standards Act of</u> <u>1938, 29 U.S.C. § 206(a)(1), whichever is greater.</u>

This action is pursuant to P.L. 2019, c.32. which increases the minimum wage, over time, to \$15 per hour.
