• The Department of Labor and Workforce Development, Division of Wage and Hour Compliance, published notice of approval of an administrative change, effective January 1, 2024, increasing the minimum wage to not less than \$15.13 per hour or the minimum wage rate set by section 6(a)(1) of the Federal Fair Labor Standards Act of 1938, 29 U.S.C. § 206(a)(1), whichever is greater.

This action is pursuant to P.L. 2019, c.32. which increases the minimum wage, over time, to \$15 per hour.
